

Install Vehicle Base:

- Remove the passenger front seat bolts (X2) using T-40 bit.
- Loosen the rear seat bolts of the passenger seat using T-40 bit.
- Lift the seat up and slide the base between the seat pedestal and seat base. Align the square holes of the base with the square pegs of the seat pedestal and tighten all the seat bolts. See Figure 1.
 Install the riser to the base at desired location and orientation using the #3/8
- 5. hardware provided.
