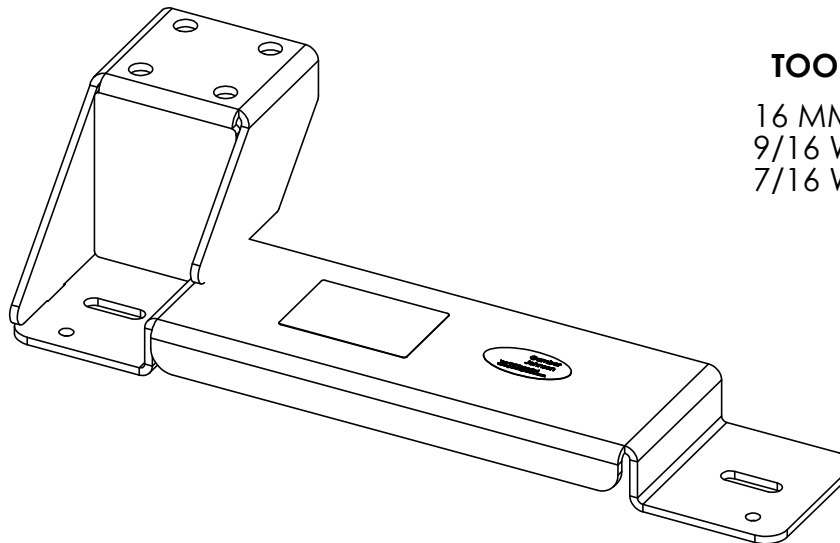

INSTALLATION PROCEDURE:

Nissan NV200 Chevy City Express

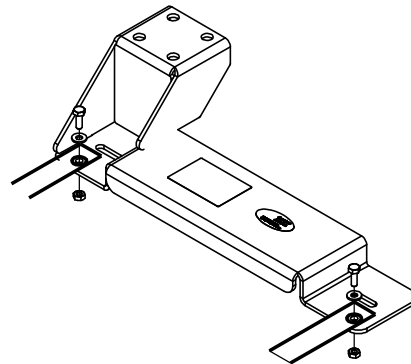
1. Remove the front seat bolts of the passenger seat using a 16 mm socket.
2. Lift the seat up and slide the base such the floor holes match the slots in the base.
3. Re-install the front seat bolts and tighten them.
4. Attach pole using 3/8-16 bolts supplied in 7120-0215 Hardware Bag.



INSTALLATION PROCEDURE:

Chevy Volt (Note: Long Support Brace 7160-0231 is required for the Chevy Volt install)

1. Do not remove seat bolts which attach the passenger seat to the floor.
2. Slide the vehicle base under the front edge of the seat rails.
3. Install .25-20 bolts, washers and nuts, supplied in 7120-0707 Hardware Bag, thru existing holes in seat rails to attach vehicle base.
4. Attach pole using 3/8-16 bolts supplied in 7120-0215 Hardware Bag.
