


The Quad-Motion series of products is designed to provide the user with slide, swivel and tilt control of their mounted device. The motion attachment allows for 60° rotation of the arm and 60° rotation of the clevis. The TS3 motion attachment allows for 3.5 in. of horizontal travel. The TS5 motion attachment allows for 5.0 in. of horizontal travel.





Tools Needed

- 7/16 Wrench or Socket

Assembly

1. Remove the (3) 1/4 in. nylon jam nuts from the bottom of the device.
2. Stack the plastic washers and metal washer as shown in Figure 1.
3. Secure the Quad-Motion device using the (3) 1/4 in. nylon jam nuts removed in step 1.
4. Tighten the (3) 1/4 in. nylon jam nuts to allow the desired rotational resistance of the arm.
5. Adjust the torque on the (4) 1/4 in. nylon jam nuts (Figure 2) on the slide to provide the desired sliding resistance.




