



### INSTALLATION INSTRUCTIONS:

1. Remove in-board seat bolts and loosen the out-board seat bolts of both driver and passenger seats using an M6 allen wrench.
2. Lift the seat up and slide the M2 vehicle Legs between the seats and the floor. Re-install the seat bolts and tighten in place.
3. Loosely attach the workstation mounting legs to the sides of the large workstation with the 3/8" hex bolts and flat washers found in hardware bag 7120-0643.
4. Set the large workstation with the mounting legs attached onto the M2 vehicle legs.
5. Attach the large workstation legs to the M2 vehicle legs with the 3/8 hex bolts and flat washers provided in hardware bag 7120-0643. Note there are multiple mounting locations for the workstation legs and the M2 vehicle legs. Tighten all the bolts to hold the large workstation secure.

### NOTE:

This Leg Kit would not work with a bench seat (60-40 seat)
